

## SO WHAT ARE THE NUMBERS ?

- Dropped Objects are among the Top 10 causes of Fatality and Serious Injury in the Oil and Gas Industry
- 2016 The <u>Bureau of Labor Statistics</u> reports there were 255 fatalities and 47,920 reported injuries from dropped objects in the United States
- Liberty Mutual Insurance alone said it paid out \$5.3 billion in workers compensation claims from 2013 to 2014. Workers comp claims don't include damage to equipment, structures and the environment.

  - Containers Portable and stationary
- Compatibility of components from different manufacturers

Establish safe working practices and procedures, across the oil and gas industry. Sets clear standards for manufacturing & testing of safety equipment


