


Dropped Object Prevention - DO YOU DO IT BETTER?

If you feel that what you are doing in your company or on your rig is better than you have seen elsewhere or is breaking ground in light of new problems or legislation, then let us know below:



- Description of Proposed Best Practice:
 - During lifting the rabbit up to the Derrick man in the Derrick observed the rabbit was attached to the elevators with a Manilla rope. As it reached the Monkey Board, and as the Derrick man removed the rabbit from the elevator to put it in Pipes and that was against with DROPS practices. (DROPS Hazard).
 - Installation of a fabricated fixed drift carrier clamp connected to links to be matched with DROPS practices and installed it for safe use during working with drift (rabbit).
 - The additional clamp (Right photo) is for installation of a safety sling for securing the drift (rabbit)

IADC Alert 02 – 03 Near Miss – Dropped Casing Rabbit

What happened:

While rih7" liner with 5-1/2" d.p, a 2-5/8" rabbit was used to drift all stands of d.p. to bring the rabbit up to the derrick man in the derrick the rabbit was attached to the elevators with a spliced rope. As it reached the monkey board, and as the derrick man removed the rabbit from the elevator, the spliced rope slipped at the splice allowing the rabbit to fall to the rig floor. As part of the 2Acompanies' procedure, the rig floor had been cleared and no injuries occurred. The near miss was reported immediately.
